Per the request of **JANE DOE**, client, 1234 Main Street, McDonough, Georgia 12345. – 123.456.7890 - phone, jdoe@email.com – email, an investigation predominately consisting of mobile surveillance in an effort to obtain a photograph was initiated on the subject, **JENNIFER DOE**, 4321 Main Street, McDonough, Georgia, 12345, 987.654.3210.

On Friday, February 15, 2008 at approximately 0500 hrs, mobile surveillance began at the residence of the **JENNIFER DOE**. The subject's residence is presently for sale for \$154,900 via www.homes.com MLS ID # 90807060. At 0559 hrs, **JENNIFER DOE** pulls out of her garage in an early model Ford Pinto, Georgia license plate ABC123 - Henry County, at an excessive rate of speed. The subject arrived at her place of employment 0629 hrs, "The Place That She Works" (<http://www.sheworkshere.org/gafpfm.php>), 123 Johnson Parkway, Johnson, Georgia, 98765, 135.246.7924, a small company that employs ten to twenty people and delivers fresh produce to local restaurants and grocery stores. **JENNIFER DOE** is employed at this establishment in the Accounts Payable Department. Due to inclement weather, video surveillance was quite limited thus far in the investigation.

At 0900, the subject departs the main facility, climbs into her privately owned vehicle, and yet again, at an excessive rate of speed drives away. At 0903, she enters the restaurant located on the "Place That She Works" Grounds only to return with a small bag in hand and returns to work. By 1100, **JENNIFER DOE** returns to the restaurant and as the weather began to calm, sufficient video evidence was obtained.
